Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 12 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school is strictly directed to conduct all the school's activities in the school's premises within the boundary wall . The school is required to maintain the school's name at the entrance of school's building and cordon off the hostel building properly with separate entry / exit within 3 months and submit the videography compliance.
3	As per the land certificate school is running on 8174.65 sq mtrs of land, however in the application land area is mentioned as 8296 sq mtrs. Thus, the school is required to apply for correction in land area on SARAS – Portal.
4	As per the land certificate para – I, land is owned by the Balmuri Santhosh Rao and Enuganti Prasad Rao by way of lease deed from 13-12-2013 to 12-12-2043 and as per para – II of said certificate, owner of the land has leased the land to Balmuri & Enuganti Educational Society. Hence, land title is not clear from the land certificate. However, school has submitted the lease deed, as per same Mr. Balmuri Santhosh Rao and Enuganti Prasad Rao are the lessor who have leased the land to school's society . Thus, the school is required to obtain renewed land certificate with correct details in the prescribed format within 03 months and submit the same in the compliance.
5	The school is required to set-up the composite science lab for secondary level, as per Board's SoP within 03 months and submit the compliance.

6	The school is using 02 rooms as library, which are undersized and there is no separate reading space for staff. However, during review the school has clarified they proposed library at second floor as per dimension. Thus, the school is required to shift the library in the said room and create a separate reading space in the same for staff within 03 months and submit the compliance.
7	The school is required to (i) affix the permanent signage at the entrance of all the labs (ii) install the railing on both of the ramp at ground level and replace the plastics chairs with wooden stools in all three science labs within 03 months and submit the compliance.
8	The school has constructed the CwSN toilets only at ground floor in one building block, which are converted by regular cubicles and does not have sufficient space for easy movement of the wheelchair, the entrance of the same is very narrow. Further, arranged the CwSN toilets in each block and at each floor separately for Boys and Girls. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor (in all the blocks) with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.
9	The school shall conduct training of its teachers with CoE Vijaywada within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws- 2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.

However, the renewed copy of Recognition Certificate no. 3000/A1/2021 dated 21.12.2021 for class I to V and Certificate no. KRMG-THMP-015-0003 dated 16.11.2021 has been uploaded under mandatory disclosure on school's website. Thus, the school is directed not to remove the same from the website. 4. As reported by IC, files maintained online can be maintained as Records offline too. 5. The school is required to develop the playground. 6. The school is required to renew all the mandatory certificates from time to time. 7. The school is directed not to remove videography link in future.

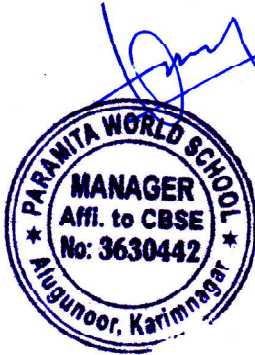
